**Reservation Terms and Conditions**

- The reservation is only effective upon receipt of the deposit and **confirmation from Camping du Coucou.**
- Your booking must be paid for in full upon your arrival. It is calculated on a nightly basis, and your pitch must be vacated before 12am on the day of departure.
- If you fail to contact us regarding a delayed arrival we reserve the right to re-let the pitch.
- You are obliged to pay the full amount due for the dates reserved, even if you arrive late or leave early.
- The campsite will do it's best to take into account any special requests you have for your pitch, but cannot guarantee to do so.

**RENTALS**

- During the months of July and August, **rentals** are made by the week from **Saturday after 4pm to Saturday before 10am. The rental must be vacated on the departure day before 10am.**

A deposit will be requested on the day of your arrival of 400 € guaranteeing loss, damages or damage to equipment.

The final cleaning of the accommodation is charged to the customer. A cleaning charge of 70 € can be billed if cleaning has not been correctly carried out.

- Animals are accepted under the conditions that they are kept on a lead at all times, and have a current vaccination certificate (to be presented at reception on arrival). An extra 2€ per night and per animal will be requested.
- One vehicle per accommodation or camping pitch. An extra 2,50€ charge will be requested per extra vehicle.
- The visitors are authorised under the responsibility of their host, after having informed reception of their presence and paying, if necessary, the 3€ free.
- The local tourist tax is addition.
- In the event of cancellation, the deposit and booking fee are forfeit. (Please note that we do not offer any cancellation insurance, but you may contact your own insurer for a policy if you wish.)
